# **SPECIAL PRESENTATION**

Jacy Stampes gave a presentation on a community project she is proposing for the town. This is a project she is doing for High School AP Program. The project is a Community bee colony. The design will be a top bar beehive. It will have an electric fence surrounding the hive and a fence outside the electric fence for added protection. Jacy will be responsible for all fundraising for the project. She will also maintain the hive through 2019 and will develop a plan for future maintenance in the town.

Mayor Schoedinger suggested running the location and fencing design by the Town Floodplain Administrator as well as the town's insurance company before the project is started.

**Discussion, Direction, Action:** 

Discussion and approval of a town volunteer to use town property at the Community Garden for a Community Bee Colony project.

Trustee Donadio made a motion to approve a town volunteer to use town property at the Community Garden site for a Community Bee Colony project and the design should be reviewed by the Floodplain Administrator for any issues with the fencing as well as the Town Insurance company regarding the design of the hive. Trustee Lenarcic 2<sup>nd</sup> the motion, which was approved unanimously.

Discussion and approval of the Stormwater Management Master Plan

Trustee Droste made a motion to table the approval of the Stormwater Management Master Plan until the December board meeting. Trustee Donadio 2<sup>nd</sup> the motion.

Discussion and approval of Resolution 11-23, Series 2017, A Resolution Amending Addendum B Water Fees, Service Charges, And Penalties Rev 6 To Waterworks Ordinance 1, 2015 for ADU's

A discussion was held concerning the issues related to charging separate bathroom fees for ADU's. Trustee Harris stated that this issue is being raised in the spirit of fairness and equability for all water customers. There are potentially 8 ADU's in town that would be affected. Trustees Yahnke and Box stated that they do not feel this is an equitable solution. Trustee Lenarcic said he is opposed to this as well.

Trustee Harris moved to approve Resolution 11-23, Series 2017, A Resolution Amending Addendum B Water Fees, Service Charges, And Penalties Rev 6 to Waterworks Ordinance 1, 2015 for ADU's.

Trustee Lenarcic 2<sup>nd</sup> the motion.

The motion failed.

Discussion and approval of Resolution 11-24, Series 2017, A Resolution approving a revised purchasing policy for CDBG DR regulations

Mayor Schoedinger stated that these are all items that we currently have in place.

The motion was approved unanimously.

Discussion of the draft Committee template

Trustee Lenarcic presented a draft of a template for town committees for further review.

Water System Operations – Excavation on Main Street this week. A leaking valve will be replaced. 2:03:30

Water Committee – The Committee is continuing to research water meters. Metering can get the town to a more equitable place. Trustee Harris said the main barrier right now is a funding source.

Elysian Park – The Environmental covenant will be on a future agenda.

Town Square – Water leak at shut off. The issue will not be addressed until the spring.

Cemetery – Trustee Droste reported that the drilling stone has been moved into place.

Town Hall Maintenance - Arne fixed the heater in the office. The heater in the JAM office will be fixed as well.
