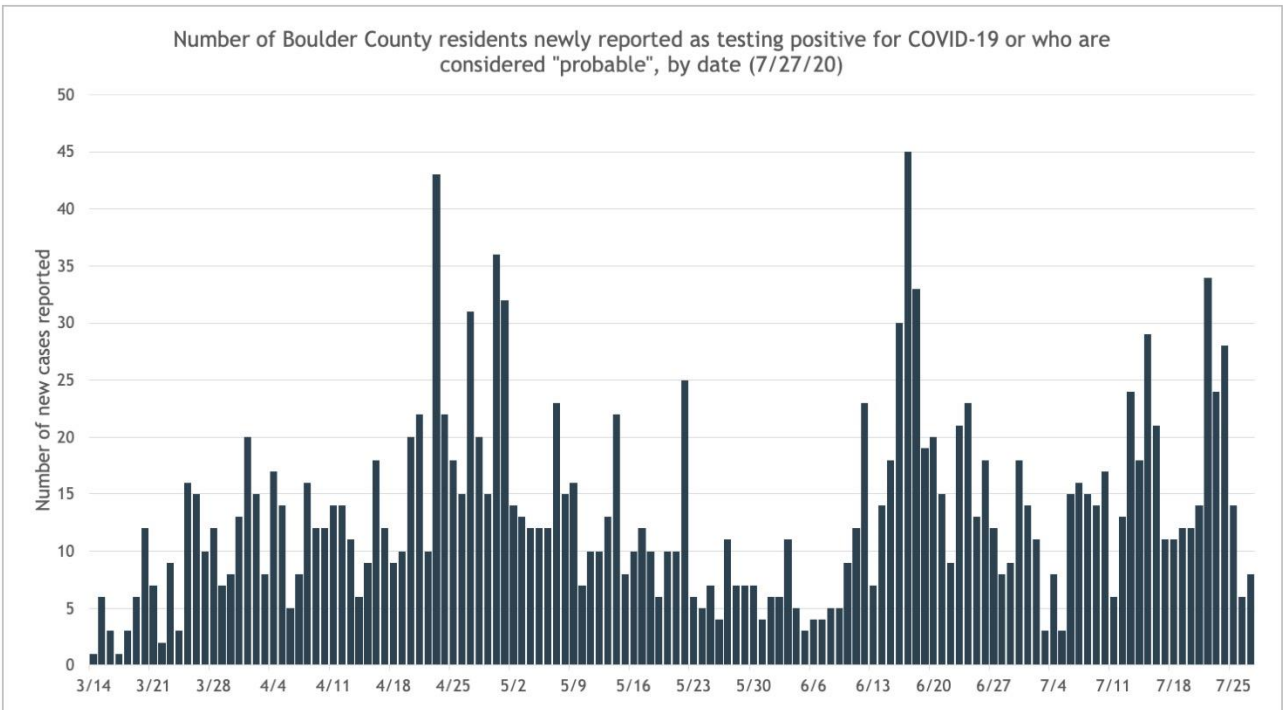


Weekly COVID-19 – UPDATE – July 30, 2020.

Boulder County continues to suffer an increasing number of positive cases and outbreaks. The graph below reflects a rolling history of positive test cases in the county during the pandemic through 07/27/2020. There were 23 positive cases on Tuesday, July 28th and 14 yesterday.



It does not look like Boulder County will be moving on to the next level of relaxation of restrictions (Protect Our Neighbors) anytime soon. The County is currently at Safer at Home in the Vast Outdoors status and heading in the wrong direction.

COVID-19 is on the rise here and all over the world. MASKS AND SOCIAL DISTANCING ARE THE MOST EFFECTIVE WEAPONS WE POSSESS AGAINST THE VIRUS.

Recently, there have been some significant Executive Orders and Public Health Order (PHO) revisions that will affect the Residents of Boulder County and the State of Colorado. The Governor and the health departments are desperately trying to correct the conflicting information the public has received about the need for masks and is making them mandatory for anyone over the age of ten (10) indoors in public places.

1. Governor Polis Signed a **new** Executive Order D 2020 138 (July 16, 2020) requiring all persons over the age of ten (10) (**formerly over the age of 12**) to wear a face covering (mask) whenever entering or moving within any "public indoor space". This includes just about everywhere indoors, other than private residences. The order also extends to places of employment, the post office and schools.

- Managers, owners and operators of “indoor public spaces” are now required to deny access or services to persons not wearing masks. Businesses who do not enforce the order risk suspension of their business or liquor licenses.
- Managers, owners and operators of “indoor public spaces” must now post signs at entrances instructing individuals of their legal obligation to wear a face covering.
- Entering or moving within does not include a person working alone in a closed office. If you share an indoor space (including cubicles) with others not of your household, you must wear a mask. Persons seated for service in a restaurant may remove their masks.
- The Governor’s order did not address outdoor use of masks except under certain conditions (waiting for a bus, train or taxi, etc.).
- The Governor also issued a **new** order that requires restaurants and bars to stop serving alcohol at 10PM although “take out” may continue.

2. On July 24, 2020, Boulder County Public Health issued a revised Public Health Order (PHO) 20-05, adopting the **new** State Order and retaining their previous language concerning the requirement for wearing a mask outdoors.

- Persons must wear a mask whenever they are outside their residence and unable to maintain, or when not maintaining, social distancing of at least six (6) feet from any non-household member in any setting whether indoors or outdoors.
- A motor vehicle is included in the term ‘residence’ when occupied by members of the same household.

For now, there are no changes in restrictions or number of persons in a gathering, uses of recreation and other town facilities or social distancing. In the absence of specific guidance, the number of persons permitted at any gathering is ten (10).
