






WATER SYSTEM UPGRADES - PROJECT APPROACH


- Jamestown Water Committee developed prioritized scope of work
 - Priority changes to date:
 - Construction Market prices are higher than previously expected
 - Water Tank more significant repairs required per inspection
 - Lower/East Mesa upgrades are required to tie into the new 6" pipe on West Mesa and 12th Street
 - Others??
- Consulting engineer's contract will be a Design To Budget
- Budget will be monitored throughout design and scope adjusted to accommodate
- If contractor bid varies from the engineer's estimate, project scope will be adjusted (either up or down)








