James & Little James Creeks Design Meeting

- Boulder County and the Lefthand Watershed Oversight Group (LWOG) are:
 - Developing stream restoration designs for James and Little James Creeks.
 - Assessing the Emergency Watershed Protection work through town.

Drainage & Stormwater Management Master Plan

- Community Development Block Grant Disaster Recovery Round 3
- \$100,000 grant for:
 - Drainage study to find solutions to drainage issues
 - Identification of stormwater management opportunities
 - 30% design for solutions
- Expect "go ahead" from State in May
 - Scoping and request for proposals
 - Project start mid summer



DOLA Funded Water System Upgrades / Road Repairs

- In progress: Construction has begun on Pine St. and 16th St. (AKA "Upper Spruce") to fix pipes that have historically caused issues on Pine & 16th St.
 - **Goal**: to address known issue areas to prevent future system failures and drinking water violations.
- This week's schedule:
 - May 3, Tuesday: Road CLOSED 8:00 4:00 PM Pine St. only.
 - May 4, Wednesday: Road CLOSED 8:00 4:00 PM Pine St. only.
 - May 5, Thursday: No closures expected. This could change depending on site factors.
 - May 6, Friday: Road CLOSED 8:00 4:00 PM Pine St. only. Water Shut-Off: 3 residences
 - May 7, Saturday: (could shift to Monday.) Road CLOSED 8:00 4:00 PM Pine St. only.
 Water Shut-Off: 3 residences
 - May 8, Sunday: No work
- Mesa St, Lower Main, Cemetery Rd. and Rose M will be graded, road based and compacted after Pine St. complete. (exact schedule forthcoming)



Andersen Hill & Bridge Reconstruction Update



- Guardrails were completed today, May 2.
- Pedestrian access will be open during non-construction hours <u>AFTER all</u> <u>guardrails are inspected</u>. Inspection is set for tomorrow, Tuesday, May 3.
- Staining is scheduled for Wednesday and Thursday, May 4-5.
- Vegetation planting will begin Friday, May 5, and last two weeks.

Town Square Restoration – Phase 1 (FEMA/CDBG-DR)


Phase 1

• Where we are starting...



GOAL: to restore the Town Square to its pre-flood elevation – includes debris removal, excavation & creating new contour lines, importation of fill and top soil.

- On April 4[,] the Town Board awarded the contract to Colt & Steel
- Phase 1 construction begins after SEMA Construction has demobilized from Andersen Hill (mid/late-May)






Town Square Restoration – Phase 2 (GOCO)

Phase 2

• Where we are headed....

GOAL: To reconstruct Andersen Hill and Bridge, the Town swapped land with the Church. The swap included some of Town Square property. Even with this, the Church gave more than they got. This adjustment resulted in moving the western border of the Town Square 25' to the east.






Town Square Restoration – Phase 2

Changes with new size:

- a) smaller size & relocation of ramada to
 - NW corner



- b) fewer trees
- c) steeper sides in order to have larger flat area
- d) added terrace
- e) Bike rack & fountain locations







Gillespie Gulch Construction Update

- Amec and the Town have worked closely with neighboring property owners, the State and FEMA to re-design the Gillespie Gulch culvert. Construction is expected to begin after the July 4th holiday.

Other Project Updates

HMGP Lower Main Street Bridge Design

- FEMA awarded the Town Phase 1 for the engineering and design of the Lower Main Street Bridge to increase its current capacity
 - 3 bids were received (see agenda item for tonight)
 - The selected engineers will provide option(s) to the Town based on FEMA edibility requirements, codes and standards, and the latest hydrology analysis
 - The selected option will be designed to 100%
 - FEMA will review the design for Benefit Cost Analysis and environmental impact to determine if additional funding will be provided for the construction
 - Design is scheduled to be complete by the end of the year

Projects at the Water Tanks

- Pipe Break Valve Project will begin as soon as we have approval from the USFS (expected within 30-45 days
- Tank painting/rehab project will begin in June November

James Canyon

• Scheduled to go out to bid in July with construction beginning in November - July
